Dear Mr. Schill and Mr. Barris:

On March 27, the House Committee on Education and the Workforce ("Committee") <u>sent you a letter</u><sup>1</sup> targeting our Community Justice and Civil Rights Clinic ("the Clinic") and its esteemed director, Professor Sheila A. Bedi. We write to remind you that you can choose to deny its unprecedented and unreasonable demands. You can choose to protect and defend the Clinic and Professor Bedi. We, alumni of Northwestern Law with backing from other Northwestern alumni, insist that you do so.

Professor Bedi is a champion of Constitutional rights and freedoms. Her tiring and often-thankless work through the Clinic has long protected the people of Chicago and everyday Americans from federal and state overreach. Many of us have proudly worked with Professor Bedi. She taught us how to—and *why we must*—oppose government overreach: not only because it is right, but because it is profoundly American. We know what it means to fight for liberty and justice. Professor Bedi shows us. She is a leader in the long march to freedom which is the American project. Therefore, it is not surprising that she and the Clinic have come under federal attack.

The Committee finds it "troubling" that clinical students work with "collectives and community organizers" on "creating a more just Chicago." We do not. What we find troubling is that the federal government would target legal scholars who have dedicated their careers to upholding Constitutional liberties. The First Amendment does not narrow its protections to those who parrot popular opinions, and the very existence of the Sixth Amendment demonstrates that the Constitution protects even those accused of running afoul of the law. All people are entitled to legal representation. Many of us have taken oaths to defend the Constitution, and we must oppose these undemocratic attacks on the First Amendment rights of Northwestern faculty and students who protect the Constitutional rights and liberties of others.

The Committee's attempts to vilify her are inconsistent with American values, principles, and traditions. The Committee's letter is unAmerican. Any capitulation by you, Mr. Schill and Mr. Barris, to current and future demands of this administration to punish the Clinic or Professor Bedi would be similarly unAmerican. We will not support a school that fails to defend its faculty members and students against government persecution. We will actively oppose such a school.

The people of Chicago need the Clinic and Professor Bedi even more during times like these, and we need you to stand beside them with loyalty and integrity. Our ask is simple: protect and defend your faculty, staff, and students, as is your job. And when these temporary political pressures subside, when that march to freedom shifts the tide yet again towards affirming justice and decency, our hope is that Northwestern University may find itself proudly on the right side of history.
